

## **Conditions of participation for the qualification of the "Masters Freestyle Aufguss"**

### **1. Subject of the conditions of participation and organizer**

(1) These conditions of participation regulate the conditions for participation in the qualifications of the "Masters Freestyle Aufguss" as well as any necessary transfer of rights.

(2) The organizer of the competition is Kristall Baeder AG.

(3) By participating in the competition and the application process, these conditions of participation are accepted.

(4) The qualifications take place in 4 spas in Europe: Kristall Kur- und Gradier-Therme GmbH Bad Wilsnack from 21.11.2024 to 23.11.2024, Thermen Bussloo B.V. 28.11.2023 – 30.11.2024, Aquagranda Livigno from 14.01.2025 to 16.01.2025 and Infinit Sen Senohraby from 22.01.2025 to 24.02.2025. The final will take place in the Kristall trimini Kochel am See GmbH from 19.03.2025 to 23.03.2025.

### **2. Participation**

(1) Eligible to take part in the competition are all those who are at least 18 years old, have experience as a sauna master, can communicate in English, have the desire and the opportunity to travel to various thermal baths in Europe and who are in good health to perform infusions/"Aufguss". Participation with fake identities or with identities of third parties is not allowed.

(2) The application is possible until October 13, 2024.

(3) Eligible participants can only be selected for qualification if they complete the registration form in full and upload a short video demonstrating their sauna-techniques.

(4) Participants in the qualification and the final declare their willingness to carry out infusions in the thermal baths that are not part of the competition.

### **3. Participation and Eligibility**

(1) Among all those eligible to participate, there are a total of 4 times 16 places for the qualifications, of which 4 participants move into the final in each qualification.

(2) The selected participants for the qualifications will be selected by a jury and informed by e-mail by October 20th, 2024. The participant must reply and confirm their participation by November 3<sup>rd</sup> 2023.

(3) Participation is not transferrable.

(4) The selected participant in the qualification agrees to sign a model release contract.

(5) The participants will receive food, accommodation and materials for the "Aufguss" for the qualification and the final from the respective thermal baths. Participants may bring one accompanying person. The journey will not be paid for. There is no participation fee.

### **4. Liability and Indemnification**

(1) If the participant uploads photos/videos, the participant guarantees that he will not send any content whose provision, publication or use violates applicable law or the rights of third parties.

(2) The participant indemnifies us from third-party claims of any kind that result from the illegality of photos/videos that the participant has used. The obligation to indemnify also includes the obligation to fully indemnify the organizer from legal defense costs (e.g. court and attorney's fees).

## **5. Exclusion**

(1) A breach of these conditions of participation entitles us to exclude the respective participant from participation. This applies in particular if the participant provides incorrect information or if the photos or other content (e.g. comments) used violate applicable law or the rights of third parties. The same applies to comments that can be viewed as glorifying violence, offensive, harassing or degrading or that violate social decency in any other way.

(2) If the excluded participant is a participant who has already been selected for the qualification campaign, the prize can be withdrawn retrospectively.

## **6. Early Termination and Amendments**

We reserve the right to prematurely end the competition in whole or in part at any time, even without observing deadlines, or to change its course if it is not possible for technical or legal reasons to guarantee that the competition will be carried out properly.

## **7. Privacy**

We are responsible for the collection, processing and use of applicants' personal data if we process it ourselves. We will only use the personal details of the participant and their other personal data within the framework of the statutory provisions of data protection law. We will only save, process and use the information to the extent that this is necessary for the implementation of the competition or the participant has given his consent. This also includes use to exercise the rights of use granted. The data will only be used to carry out the competition and will then be deleted.

The participant can request information about the data stored about his person at any time. For the rest, our data protection declaration applies accordingly, can be called up at <https://saunamasters.de/datenschutzbelehrung/>.

## **8. Final Provisions**

(1) If the Conditions of Participation contain invalid provisions, the validity of the remaining conditions shall remain unaffected.

(2) German law applies. Legal action to review the draw is excluded.
